Abstract:

Scope and Content:

Watercolor and pastel; mixed media; linocut and block print; letterpress, serigraph; and cel vinyl on acetate. Subject matter and locale covers the city of Los Angeles, California. Background Note:

The CRA/LA, a Designated Local Authority donated artwork to various southern California cultural institutions that were previously owned by the now-dissolved former agency, the Community Redevelopment Agency of the City of Los Angeles. The Natural History Museum of Los Angeles County received a portion, including the original art on paper managed by the Seaver Center but also paintings and other works of art managed by the Material Culture section of the History Department.
