Abstract:

The Greater Los Angeles New Car Dealers Association (GLANCDA) Historical Records collection is comprised of bound albums; reports and scrapbooks; photographs; newspaper clippings; floor plans; and ephemera pertaining primarily to the Los Angeles Annual Auto Shows and activities sponsored by the Association and its predecessors. The association went through several name changes over its more than one-hundred-year history, beginning in 1905

with the earliest precursor organization the Automobile Dealers Association of Southern California.

Historical Note:

The first Los Angeles Auto Show was sponsored by the Automobile Dealers Association of Southern California (Licensed Motor Car Dealers Association of Los Angeles), and was held January 21-27, 1907 at Morley Skating Rink on Grand Avenue between Ninth and Tenths Streets (Director's Minutes Fall 1906.) Throughout the early years the Los Angeles Auto Show changed venues in and around downtown Los Angeles and was held in January, the later shows were held in late October to early November. The 1910 show site was in Fiesta Park, Los Angeles which was located in a block bordered by Grand Avenue, 12th Street, Hope Street, and Pico Boulevard.¹ No Auto Show was held during 1918 "because they would have been considered unpatriotic." (Board Minutes, 1918). The 8th Annual Auto Show (1919) was held in Prager Park, Los Angeles located between Grand Avenue, Washington Boulevard and Hill Street. The 1920 Auto Show was held in large tents and the venues continued to be Prager Park, and Washington Park. During the years 1923-1926 the Motor Car Dealers Association of Los Angeles also sponsored an "Enclosed Auto Show" at the Biltmore Hotel in Los Angeles.

On March 5, 1929, soon after the auto show opened, there was a great fire caused by an electrical circuit in one of the airplane exhibitions which caught fire and destroyed all the new cars in the show. Estimates of the damage range from about \$1 million to \$1.25 million (in 2020 dollars, the estimate is about \$25.1 million to \$31.4 million). Newspapers reported that were around 2500 attendees who watched as the fire burned. As many as 380 cars were destroyed, among them Auburn Automobile Company's one-off cabin speedster, a two-passenger bicycle-fendered, boattail coupe that had previously received praise at the 1929 New York Automobile Show. The

show was moved the next day (March 6, 1929) to the Shrine Auditorium and Exposition Hall on West Jefferson Boulevard, which was the show venue through 1932.²

In 1933 the show venue moved to Wilshire Boulevard at Fairfax Avenue. Once the Pan Pacific Auditorium (7600 West Beverly Boulevard, Los Angeles) opened in 1935, the annual auto show relocated to there and continued until the site closed in 1972. The sponsors then moved the show to the Los Angeles Convention and Exhibition Center on Figueroa Street, where it continues today. The LA Auto Show went on hiatus beginning with World War II through 1951.³

Scope and Content:

The Greater Los Angeles New Car Dealers Association (GLANCDA) Historical Records collection is comprised of bound albums, reports and scrapbooks; photographs; newspaper clippings; auto show exhibitor floor plans; and ephemera pertaining to the Los Angeles Annual Auto Shows activities sponsored by the Association and its predecessors. The association went through several name changes over its more than one-hundred-year history, beginning in 1905 with the earliest precursor organization the Automobile Dealers Association of Southern California.

There are more than 800 photographs covering the Los Angeles Annual Auto Shows, 1917-1969 and portraits of the directors and officers dating circa 1910 through 1970s. The majority of the Auto Show images date to the years 1935-1970 when the event was held at the Pan Pacific Auditorium, 7600 West Beverly Boulevard, Los Angeles, California. There are also images from the late 1980s featuring members events of the Greater Los Angeles New Car Dealers Association.

Bound albums/ledgers contain meeting minutes of the Board of Directors and members (1905-1920). The albums reflect the earliest activities of the organization under the following names: The Automobile Dealers Association of Southern California, the Motor Car Dealers Association of Los Angeles, and the Licensed Motor Distributors Alliance of Los Angeles.

Bound reports for the Los Angeles Annual Auto Shows, 1919 to 1939. The majority of these reports contain audit and finance reports, member and exhibitor listings, daily gate records, examples of passes, forms and stationery, annual brochures, "General Information and Rules for Exhibitors," "Auto Show Communication Bulletins," and photographs have all been digitized.

Newspaper clippings for the 25th Anniversary of the Auto Show in 1937 include publicity and articles about the show. There are scrapbooks and entire special auto sections mainly from the *Los Angeles Times* and the *Los Angeles Herald*.

Additional items include floor plans for circa 1920s auto shows; and ephemera from 1968-1972 Auto Shows, such as Auto Show Magazine and tickets.

Collection Content:

Series 1: Photographic Series 1910-1987 (Boxes 1-15)

The Photographic Series includes portraits of the directors and officers, auto show stills from the early 1900s through the 1960s, and photographs of members' events. All the photographs are organized by the way they were housed in the original albums, files and boxes.

- The shows dating between the 1920s through the 1960s were sponsored by the Motor Car Dealers Association of Los Angeles and the Los Angeles Motor Car Dealers Association. The Los Angeles Auto Shows starting in the mid-1980s were sponsored by the Greater Los Angeles New Car Dealers Association.
- The auto shows for 1935-1971 were held in the Pan Pacific Auditorium, with the majority of the photographs taken by Art C. Streib who was the official photographer for the show. His credit lines are stamped on the verso and include with the photography studio name and the studio's negative number.
- Credit lines for Art Streib appear as follows: Art. Streib (120 1/2 S. Broadway, Los Angeles and 130 S. Broadway, Los Angeles date: circa 1920-1930s); Art Streib (955 South Hope Street, Los Angeles, date: circa 1930s-1950); Art Streib Studio (955 South Hope Street, Los Angeles, date: circa 1950-1955) and Art Streib Photographers (1972 Hillhurst Ave. Los Angeles, date: circa 1955-1970)
- The 1950s-1960s photographs are arranged as they were filed in the original yearly binders/albums. Some of the years include panoramic views of the show room. The panoramic view consists of 2 8x10" images scotch taped together on the verso.

This series is arranged as follows: Los Angeles Auto Shows 1950s-1960s (Boxes 1-12), Los Angeles Auto Show Miscellaneous Stills 1910-1960s (Boxes 13-14), and Portraits of Directors and Officers 1910-1987 (Box 15). The primary photographers include: Gladser Studio, Los Angeles; Murillo, Los Angeles; and Arthur C. Streib.

Series 2: Meeting Minutes of the organization 1905-1920 (Boxes 16-17 oversized)

This series includes four large ledger/minute books for the years 1905-1920 starting with the earliest organization: Automobile Dealers Association of Southern California (1905-1911) which was then taken over by the Licensed Motor Car Dealers Association of Los Angeles (1909-1920) also known as the Motor Car Dealers Association of Los Angeles. The earlier minutes also include the reports for the Annual Automobile Shows. The ledgers in this series were not digitized due to their fragile nature.

On page 56 there is a letter from the Secretary of State (California) dated March 6, 1911 indicating that the association owed back taxes for 1910 and would be dissolved. April 6, 1911 the association was dissolved.

Series 3: Annual Reports for the Los Angeles Automobile Shows 1917-1939 (Boxes 18-20)

This series is comprised of bound annual reports sent to the members of the Association. Each report includes information regarding income and expenditures, attendance, and in most instances the programs, invitations, different types of tickets, and agreements. The auto shows for this series were sponsored by the Motor Car Dealers Association of Los Angeles (MCDALA) and sponsored by the Los Angeles Motor Car Dealer Association (LAMCDA). Many also include an Auditor's reports and photographs of the displays. For the earlier reports on the annual automobile show see the minutes of the Board of Directors in Series 2.
